  - a. conduct recruitment process for the position specified in the advertisement for the post of an ASSISTANT PROFESSOR in the research staff member group at the Institute of Applied Computer Science of the Faculty of Physics, Astronomy and Applied Computer Science academic field Theoretical Physics as part of the project implementation “New physics in light of the primordial remnants from the early universe” – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement for the post of an ASSISTANT PROFESSOR in the research staff member group at the Institute of Applied Computer Science of the Faculty of Physics, Astronomy and Applied Computer Science academic field Theoretical Physics as part of the project implementation “New physics in light of the primordial remnants from the early universe” based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator.
